The refreshed plan states that:

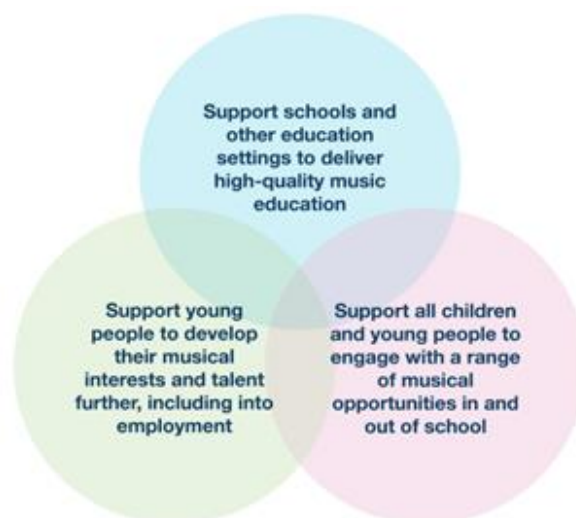
“Every school should be able to articulate their plan for delivering high-quality music education and supporting pupils to progress, just as they would in any other curriculum subject.”

The Department for Education has set out their one vision, three aims and five strategic functions for Music Hub partnerships:

One Vision:

“Enable all children and young people to learn to sing, play an instrument and create music together, and have the opportunity to progress their musical interests and talents, including professionally.”

Three Aims:



The 5 strategic aims are:

- Partnerships
- Schools
- Progression and musical development
- Inclusion
- Sustainability

MK Music Hub, which is funded by the Department of Education, can support all schools and settings to develop their plans for music education, including writing School Music Development Plans.

We can:

- Provide curriculum music where required to fulfil the DfE requirement of at least 1 hour per week for KS 1-3
- Provide subsidised Whole Class Ensemble programmes
- Offer Nurture groups and well-being sessions
- Offer instrumental projects to young beginners

Many opportunities for schools are offered free of charge by the Hub including:

Subject Leader meetings Primary, Secondary, SEND
Music Mark Membership (if a school is offering an excellent music education)
An annual meeting with a representative of the music hub to discuss music provision
Roadshows/Concerts/Live performances
Music education workshops

Terms and Conditions

General:

BEFORE BOOKING Please note – We will always do our best to accommodate requests from schools but it is impossible for us to offer an afternoon session to every school. Please keep this in mind when ordering provision and try to be as flexible as possible. This will enable us to provide teaching for as many schools as possible.

As well as terms and conditions specific to projects as set out in this booklet, the following will apply:

The Music Hub will:

- Provide teaching over a minimum of 34 weeks and a maximum of 36 weeks.
- Support Music in your school.
- Support the class teacher to assess progress during projects.
- Deliver and collect instruments.
- Monitor the quality of teaching provided.
- Carry out stock checks of instruments being used by the school in line with MK Council internal audit requirements.
- Provide a planning overview where requested.

Schools will:

- Provide appropriate space and resources for the class/group to ensure a good learning environment.
- Prioritise booking a Whole Class Ensemble Programme. (IN3A, IN3B and IN3C).
- Ensure a member of staff supports the delivery of all WCET projects (IN3A, IN3B and IN3C). This can be a teaching assistant or a class teacher but needs to be the same member of staff every week.
- Ensure all pupils who have received WCET have the opportunity to continue with instrumental lessons.
- Ensure that all children have equal access to music sessions.
- Ensure class teachers are aware of pupil progress during music projects.
- Provide details of the school's behavioural policy.
- Provide details about each class - names, SEND, behaviour etc.
- Ensure that all Music Hub instruments are checked on arrival and departure, are signed for and are part of the school's audit procedures.
- Continue support in music sessions for those pupils that need it (including 1:1 support).
- Complete the annual Arts Council return.

Length of Agreement:

When booking, schools commit to the agreed programme for the period advertised.

Method and timing of payments:

Schools will be invoiced on a termly basis. The Music Hub will supply schools with written confirmation of services purchased.
